

A consumer medicine information (CMI) leaflet is designed to inform consumers about prescription and pharmacist-only medicines. It provides information about a medicine and is written by the pharmaceutical manufacturer.

A CMI gives you important facts to know before, during and after taking your medicine.

Where can you get CMIs?

Sometimes you can find CMIs inside the packet or box, or:

- ▶ Download them from the NPS website at www.nps.org.au
- ▶ Ask your pharmacist or doctor to print it for you.
- ▶ Phone Medicines Line on 1300 633 424 for the cost of a local call. You can ring Mon-Fri, 9am-5pm, Eastern Standard Time.
- ▶ Contact the medical information department of the pharmaceutical company that made your medicine. Find their number in the phone book.

Using a CMI

To ensure you have the right CMI, check that the brand name on the CMI (usually the largest text) exactly matches the brand of your medicine. Always read the entire CMI before taking a new medicine.

Read a CMI to ensure you get the best and safest use of the medicine, or to learn more about a medicine you're already taking. Take it with you to your doctor or pharmacist to discuss any questions about medicines.
